# 8.1 ADVOCACY REGARDING CLOSURE OF TARGET STORE

The purpose of this report is to provide options for Council to consider in response to the proposed closure of the Maryborough Target store by its parent company, Wesfarmers Ltd. The Target store is expected to close in March 2021. Council has an opportunity to express to Wesfarmers its disappointment in the decision given the impact on High Street and loss of local employment. Correspondence to Wesfarmers could include requesting that increasing employment opportunities at its Kmart store be considered.

Write to Wesfarmers Ltd to express its disappointment in the decision to close the Maryborough Target store, given the loss of local employment and potential flow-on impacts on the shire's core retail precinct, and request that increasing employment opportunities at its Kmart be considered; and
