All food, grain or chaff is kept in vermin proof receptacles.

### **Animal Welfare:**

The permit holder must keep any animal on the property in accordance with

- (a) Prevention of Cruelty Act 1986
- (b) Domestic Animals Act 1994
- (c) Any relevant Code of Practice under these Acts

#### **Animal housing:**

Must be located far enough away from any habitable room windows of a neighbour to minimise possible nuisance by noise or smell.

Any structure used for animal housing must be cleaned and always maintained in a sanitary condition.

The land within 3 meters of an area or structure in which animals are kept must be free from dry grass, weeds, refuse, rubbish, or other material capable of harbouring vermin.

### Adequate Fencing

The holder of the permit must ensure that the land is adequately fenced and secured to prevent the animal's from escaping from the property.

#### **Animal Excrement**

All manure and other waste are disposed of and/or treated as often as necessary so that it does not cause a nuisance to neighbours or conditions that are offensive.

#### **Animal Nuisance**

Permit holder must not allow any noise, smell, or refuse to emanate from property so as to interfere with or endanger the health and reasonable comfort of any person in any other premises.

#### **Penalties**

The holder of any permit shall ensure that the conditions of the permit are always adhered to. If an Authorised Officer reasonably believes a breach of the permit conditions has occurred enforcement action may be taken and the permit may be revoked.
